## American Society for Pain Management Nursing® Dr. Jo Eland, Excellence in Pediatric Nursing Award

### **Purpose:**

The *Dr. Jo Eland, Excellence in Pediatric Nursing Award*, originally established in 2011 as the ASPMN® Nurse Exemplar Award, is presented to a nurse in recognition of outstanding contribution to the field of pain management for the pediatric patient. Self-nominations are encouraged.

### **Selection and Notification:**

All nominations or applications and accompanying documents must be submitted via the online application site by the deadline noted on the website. The Achievement and Recognition Committee will review applications/nominations to select the recipient.

The following format and criteria will be used to select a nurse for recognition at the American Society for Pain Management Nursing® National Conference.

### **Eligibility Requirements:**

Nominees must:

- Be a member of ASPMN®.
- Serving as a Board member, committee chair, or on a committee is an asset but not a requirement.
- Demonstrate ethical integrity that includes behaviors such as fairness and honesty.  
Demonstrate leadership and outstanding contribution to the field of pediatric pain management nursing.
- Demonstrate a history of extensive participation in pediatric pain management nursing practice, education, and/or research.

### **Nominees Must Meet the Following Criteria:**

- ✓ Maintain standards of clinical pain nursing practice.
- ✓ Use creative techniques in patient care and/or education.
- ✓ Serve as a patient advocate.
- ✓ Promote collegiality through demonstration of collaborative efforts with other healthcare team members.
- ✓ Serve as a role model by fostering respect among healthcare team members.
- ✓ Maintain an outstanding level of skill and knowledge in managing patients with pain.
- ✓ Simulate nursing colleagues to improve patient care.
- ✓ Initiate outstanding contributions to improving the image and clinical practice of pain management nursing.

**Process for Application:** Nomination must be submitted by an ASPMN member.

1. Complete online application form
2. Statement from the nominator that indicates the number of years the nominee has been practicing in pain management, how long the nominee has been a member of ASPMN, ASPMN activities in which the nominee has been involved and the length of time and capacity in which the nominator has known the nominee.
3. Statement from the nominator which addresses the above eight point criteria.
4. One letter of recommendation from an individual other than the nominator that outlines achievements and contributions of the nominee (see above criteria) including examples of exceptional practice.
5. A current copy of the nominee's curriculum vitae.

**Award:**

The ASPMN® Dr. Jo Eland, Excellence in Pediatric Nursing Award recipient will receive:

- A complimentary registration to one ASPMN® National Conference
- Recognition at the American Society for Pain Management Nursing® National Conference
- Recognition in ASPMN®'s *E-News*.
